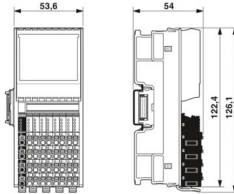

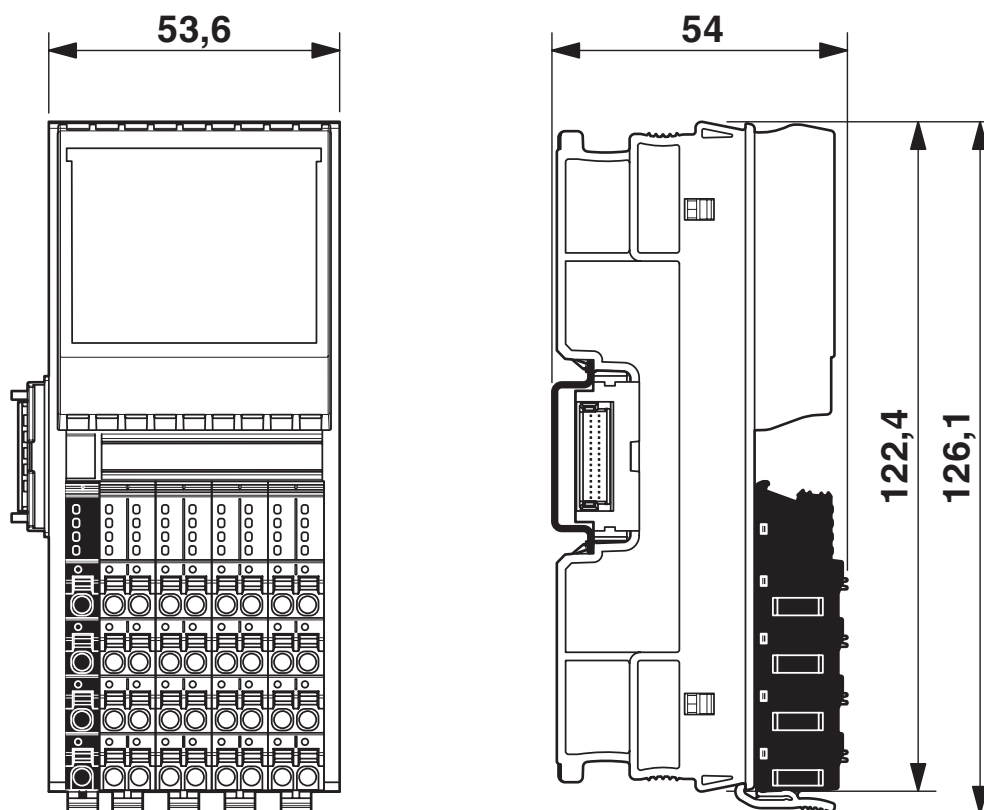

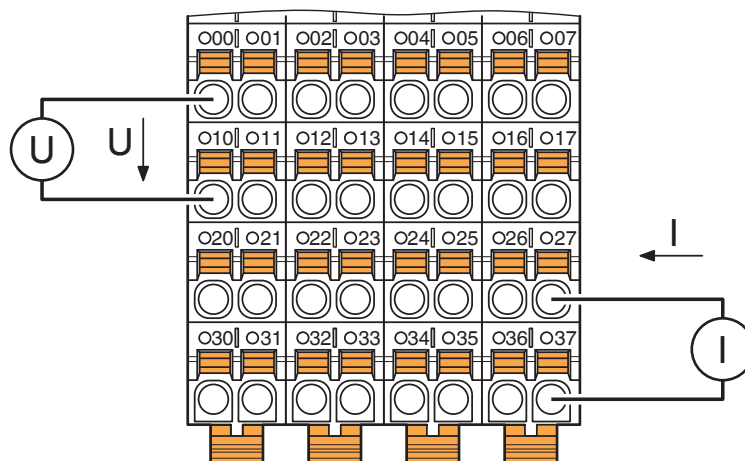

Connection for voltage and current measurement

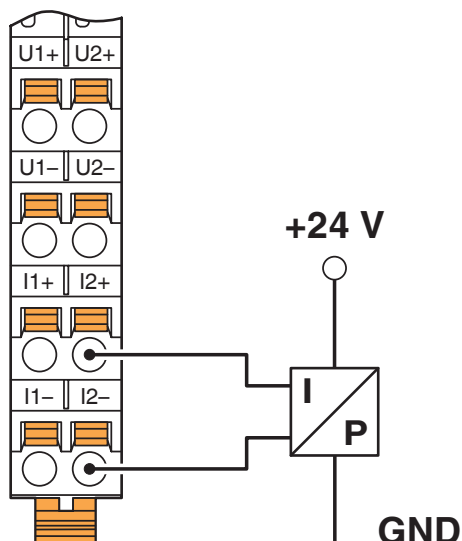

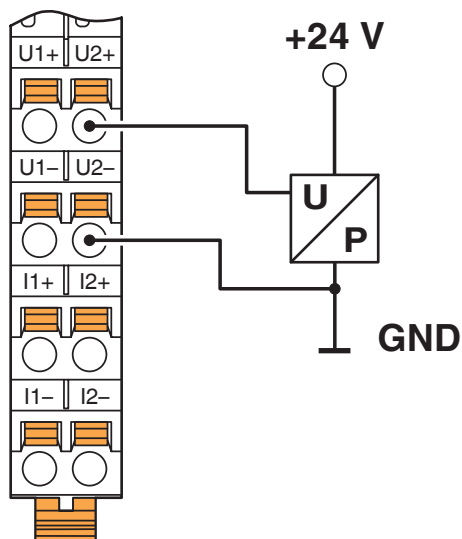


Connection diagram

Differential voltage input with active 3-conductor transmitter

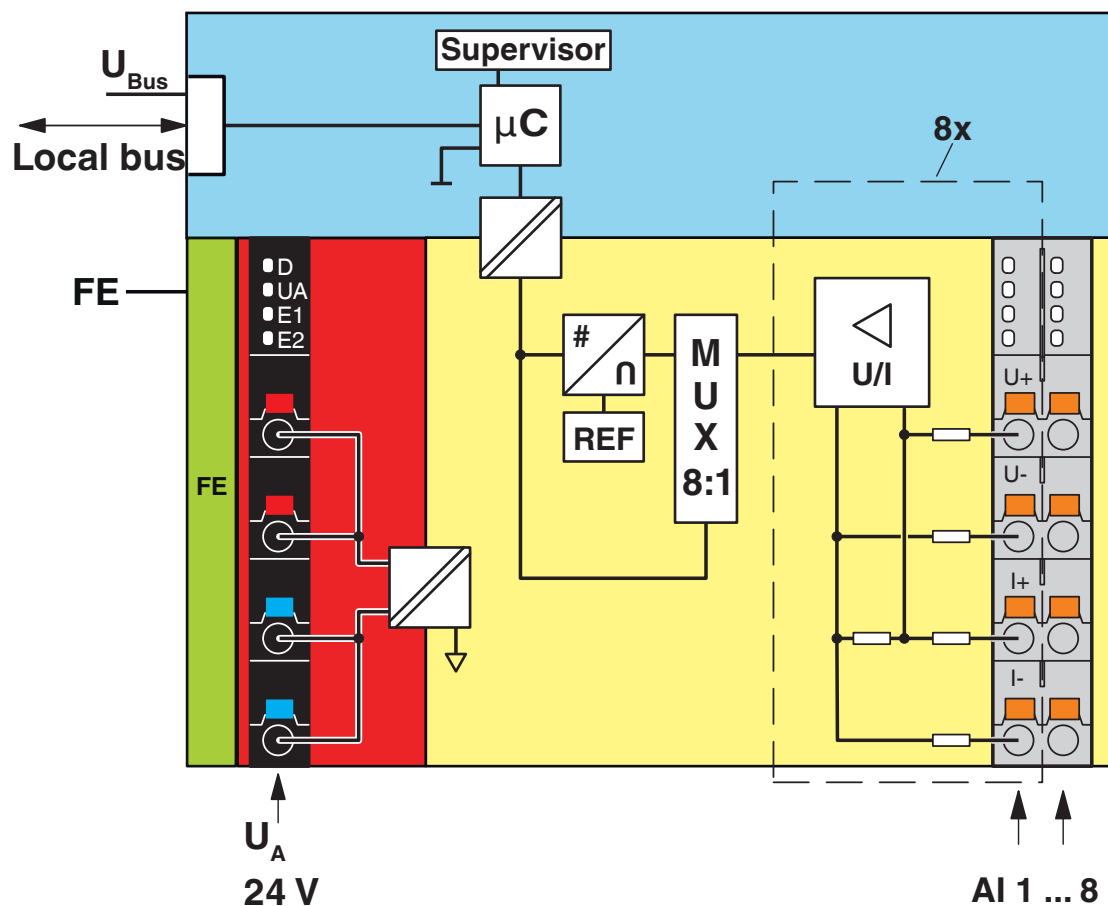
